ORDER

Subject: Resorting to malpractice by producing fake Domicile certificate in Constables(GD) in CAPFs, NIA &SSF and Rifleman(GD) in Assam Rifles Examination,2015 -Cancellation of Candidature & Debarment.

WHEREAS, Shri Bhupender S/o Shri Rajbir residing at Vill. Model Village, PO, Kimin, Teh. Yapia Distt Papum Pare, Arunachal Pradesh-791121 was a candidate bearing Roll No. 1601090230 **Constables(GD) in CAPFs, NIA &SSF and Rifleman(GD) in Assam Rifles Examination,2015** conducted by Staff Selection Commission (hereinafter called the Commission), which was notified in the Employment News/ Rozgar Samachar dated 24.01.2015; and,

2. **WHEREAS**, Shri Bhupender was provisionally recommended for appointment to the post of Constable (GD) in CISF through the aforesaid examination; and,


3. **WHEREAS**, CISF informed the Commission that Domicile Certificate submitted by Shri Bhupender at the time of the said exam was verified from the issuing authority i.e. O/O Deputy Commissioner, Papumpare, Yapia, Arunachal Pradesh and it come to their notice that the said Domicile Certificate was not issued by the office of Deputy Commissioner, Papumpare, Yapia and no such issuance in the name of Shri Bhupender was found in their Office record. It, thus appeared that Shri Bhupender produced fake/forged Domicile certificate at the time of documentation, and the CISF had cancelled his candidature vide their letter No. E-32015/CISF/GHG/Comb. Rectt (Ct/GD)-15/Adm.1/2017-1831 dated 12/8/2017; and,

4. **WHEREAS**, the Commission, the Competent Authority in the matter has made a conscious decision with a view to protecting the integrity of the selection process and to prevent candidates who are prima facie found to be indulged in unfair means in such examinations for entering into service through manipulating practices; and,

5. **THEREFORE**, candidature of Shri Bhupender for aforesaid exam is cancelled and is debarred from appearing in the Commission's examinations for a period of 03 years as per details given below-
