- (i) **Medical Certificate** seeking exemption in prescribed format (**Annexure XVI** of the notice of Examination) from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution declaring him to be permanently unfit for the Typing Test because of a physical disability.
- (ii) PwD certificate from notified Medical Authority as per Annexure-XIII(Form V) to Annexure-XV (Form VII), whichever is applicable, as per the notice of the examination.
- (iii) Undertaking as per the format annexed to this notice.

However, **such exemption is not available** for the posts where either Computer Proficiency is prescribed (**as mentioned at Para 13.8.10**) or where DEST is prescribed (**as mentioned at Para 13.8.11.4**) except for the post of the Tax Assistant in CBDT, for which exemption from attempting DEST is available. All other PwD candidates are not eligible for exemption from the Skill Test (DEST).

Alternatively, the candidates may also report at the venue of Tier-II on date of their Paper-I along with aforementioned documents (Original & Photocopy) for seeking exemption from DEST.

The candidates are required to produce all the aforesaid documents in original before the Commission at the time of Document Verification. If any candidate fails to produce the same during Document Verification, Commission would cancel the candidature of such candidate for this exam and such candidates will have no claim against the Commission's decision.
