- You must bring all the Original Certificates & documents, as applicable as per eligibility condition(s) attached to the post(s) applied for, for producing the same before the Commission during the Documents verification, failing which, your candidature will liable to be cancelled. You must bring original certificate of the following documents & submit one set of its self-attested copies:-
