- Date of Birth.
- Essential Qualifications as per Recruitment Rules and/or as per advice, if any, of Indenting Department as on the crucial date.
- Age relaxation claimed by the Candidate, if any.
- SC/ST/OBC/EWS/EXs/PH Certificate issued by the Competent Authority.
- The eligibility of the candidates whose candidature has been kept provisional for reasons other than OBC status should be verified.
- Photo, Signature, Left Thumb Impression and handwriting taken on Admission Certificate (Commission's Copy) and on documents obtained at different stages of Examination need to be verified with those the candidate may actually submit at the time of joining the service.

3. In addition, pre-appointment formalities such as Character and Antecedent Verification & Medical Examination etc. of the candidate may also be completed as per extant Rules and Regulations of the Government.
4. In case where offer of appointment has been sent to the candidate and the candidate has sought extension of time of joining the post, the same may be considered in accordance with the guidelines contained in DOPT OM No. 9/23/71-Estt.(D) dated 06.06.1978 and OM No. 35015/2/93-Estt.(D) dated 09.08.1995.
5. If the candidate declines the offer of appointment or fails to report the duty, or there is no response from him/her even after reminder(s) (through Speed/ Registered Post with acknowledgement), the offer of appointment should formally be cancelled and the candidate informed accordingly. The dossier of such candidate may, thereafter, be returned to the Commission after placing therein a copy each of the offer of appointment, subsequent reminder(s) and the memorandum of cancellation of the offer of appointment.
6. Offer of appointment to the candidate(s) nominated through this letter should be issued at the earliest possible so that the candidate(s) need not have to wait for unduly long periods and also the vacancies in question are filled expeditiously.
