Or National Apprenticeship Certificate (NAC) of 3 (three) years duration in Electronics Mechanic/ Electrician trade under Apprenticeship Training Scheme from a Government recognized IT/ ITC with 1 (one) year of work experience in the trade from Government Department/ Public Sector undertaking/ reputed concern.
